**Explanation of Responses:**

- Represents the satisfaction of tax withholding obligations upon the vesting of restricted stock units.
- Represents vesting of one-fourth of restricted stock units granted on September 20, 2019. The balance of the award is scheduled to vest on September 20, 2023. Each restricted stock unit converts into a share of class A common stock on a one-for-one basis.
- Represents vesting of one-fourth of restricted stock units granted on September 20, 2019. These restricted stock units were granted subject to achievement of a performance condition, which condition was determined to have been achieved. Therefore, the balance of the award is scheduled to vest on September 20, 2023. Each restricted stock unit converts into a share of class A common stock on a one-for-one basis.
- Represents vesting of one-third of restricted stock units granted on September 20, 2021. The balance of the award is scheduled to vest in two equal installments of 5,237 shares on each of September 20, 2022 and September 20, 2023. Each restricted stock unit converts into a share of class A common stock on a one-for-one basis.
- Represents vesting of restricted stock units granted on September 21, 2020. The balance of the award is scheduled to vest in two installments of 5,163 shares on September 21, 2023 and 5,164 shares on September 21, 2024. Each restricted stock unit converts into a share of class A common stock on a one-for-one basis.
- Represents vesting of restricted stock units granted on September 21, 2020. These restricted stock units were granted subject to achievement of a performance condition, which condition was determined to have been achieved. The balance of the award is scheduled to vest in two installments of 5,163 shares on September 21, 2023 and 5,164 shares on September 21, 2024. Each restricted stock unit converts into a share of class A common stock on a one-for-one basis.
